My areas of expertise are poverty law, public benefits, and Medicaid specifically. Finally, I did not learn to drive until I was 30 years old. I relied on bus, train, and bike transportation. I think making sure the Public Works and/or Planning Commission is taking account of the positions of people who rely on these forms of transportation is imperative to sustain growth and ensure equity.

As a commissioner on your preferred commission(s), how could you contribute to the City's equity and inclusion initiatives?

I would enthusiastically support all initiatives to address systemic racism, sexism, ableism, etc. I have studied and participated in social movements aimed at social justice and equity. We live in a time of isolating and destructive political division. I believe it is my duty as a citizen of Roseville, MN, and of the United States, to: recognize that the systems that of economic and political power over the course of my life, and generations before me, have had the effect of limiting access to support, opportunity, and power for many people; and to keep trying to unravel those systems that unjustly advantage some people over others. Until an issue is experienced, people don't often think about everything Public Works touches, but they literally ensure people can travel about, have safe drinking water and waste disposal, public utilities available when and where required as well as other important day to day needs. Working WITH our

environment, rather than trying to bulldoze our way through is pivotal to creating a sustainable relationship with our surroundings. Taking the environment into consideration with how we manage our City initiatives is just as critical as establishing and adhering to a budget. Ensuring people can move about our great city safely and efficiently improves quality of life and provides people with the means necessary to handle their day to day activities. Essentially, these City functions ensure people have access to the amenities we all require (but often take for granted!). I would love to serve on this Commission as a means of giving back to our Community being I've benefited greatly from all these services and considerations for the Big Picture.

I am also applying because I believe it's important to be involved locally. Far too often, people are quick to have an opinion but slow to get involved. I want to help bring the voice of our citizens to our City Management and Council.

I am a project manager by trade and work in a hybrid role between Tech and Construction for a major retailer. I help ensure hardware is successfully deployed within large-scale Remodel projects. I partner with a wide variety of people from Planning, Sourcing, Procurement, Supply Chain Management and Execution to ensure the millions of dollars invested into these initiatives are executed as efficiently and on-time as possible. This background helps me understand the Whys and the Hows as well as looking to understand how decisions made currently will affect the broader landscape downstream. I believe this perspective and experience would aid me in reviewing and contributing to the various topics covered by the PWET Commission.

Additionally, I am very passionate about the environment and have been organizing litter pick-ups throughout the City of Roseville since 2013. I partnered with our Public Works Streets Super Steve Zweber early on for assistance with supplies and pick-up of the collected waste. I then partnered with Roseville's Volunteer Coordinator to formalize this model as I knew there were other folks like me in the community who were doing the same thing: picking up when they noticed an area needed attention.

Another topic I am very passionate about is pedestrian traffic. I live off County B between Rice and Dale which is a heavy pedestrian traffic area with Met-Transit bus stops at both Rice and Dale, as well as several school bus stops along B. I believe everyone has the right to move safely from Point A to Point B. Because of this, I often follow up with Ramsey County and the City of Roseville regarding unsafe pedestrian situations, whether it be vehicle speed, needed snow removal or painted cross-walks. I am happy to continue making those who manage these spaces aware of potential hazards, but I would like to get more involved and help identify patterns and areas of opportunity proactively, hence my interest in applying for a seat on this Commission.

Commissioners are an important conduit between our community and City Management and Councilmembers. Taking ALL people into consideration when contemplating the needs of our City is a non-negotiable.
