Consideration to approve a Proclamation, and two Resolutions declaring a local

emergency in the City of Roseville.

BACKGROUND

Due to the ongoing situation in Minneapolis and St. Paul due to the death of George Floyd while in custody of the Minneapolis Police Department, Mayor Roe declared a local emergency and curfew in the City of Roseville through June 1, 2020 at 5:00 p.m. On June 1, Governor Walz announced the curfew in Minneapolis and St. Paul will be extended for two additional days from 10 p.m. to 4 a.m.

Staff recommends extending the local emergency through Monday, June 8 and the declaring of a curfew for the evenings of June 1 and 2 with the option of extending the curfew by the City's Emergency Manger during the local emergency period.

FINANCIAL IMPACTS

Declaring a local emergency is designed to allow the city to be more nimble in its response and able to recover its costs from the emergency.

MAYOR'S PROCLAMATION DECLARING A LOCAL EMERGENCY

WHEREAS, the Mayor of Roseville finds that the following factual situation exists:

- 1. The cities of Minneapolis and St. Paul, Minnesota, have experienced widespread civil unrest since at least May 26, 2020.
- 2. Said civil unrest has included violent and destructive acts that have placed public safety at risk and resulted in near catastrophic property damage.
- 3. The City of Roseville geographically borders both Minneapolis and St. Paul.
- 4. Reports and observations of local law enforcement personnel and emergency first responders establish that as of May 29, 2020, incidents of said civil unrest have been observed within the City of Roseville.
- 5. The law enforcement personnel and emergency first responders for the City of Roseville expect violent and destructive acts of civil unrest to continue and escalate without invocation of certain portions of the City's emergency management plan, as established under Chapter 107 of City Code.

WHEREAS, the Mayor finds that the factual situation is sudden, unforeseen, and could not have been reasonably anticipated as it currently exists;

WHEREAS, the Mayor finds that the factual situation threatens the health, safety, and welfare of the residents of and property within the City of Roseville;

WHEREAS, the Mayor finds that conditions within the City of Roseville have the potential to worsen quickly and without notice due to the factual situation;

WHEREAS, the Mayor finds that traditional governmental processes are unable to appropriately protect the safety and property of the general public;

THEREFORE, pursuant to Minnesota Statutes Section 12.29, the Mayor of Roseville proclaims and declares a local emergency effective as of 5:00 p.m. on May 29, 2020. Under state law, this declaration shall last no longer than three days unless extended by and through the consent of the Roseville City Council.

This declaration immediately invokes all necessary portions of the City's emergency management plan including, but not limited to, the establishment of a City-wide curfew for all persons within the City of Roseville from 8:00 p.m. through 6:00 a.m. for the duration of this declaration. The curfew does not extend to people traveling to or from work, emergency services, law enforcement, people seeking emergency medical care or fleeing danger, the homeless and the news media.

The declaration shall be given prompt and general publicity.

RESOLUTION TO EXTEND PERIOD OF LOCAL EMERGENCY

WHEREAS, Minnesota Statute § 12.29, subd. 1 allows the governing body of a local government to extend the period of a local emergency declared pursuant to Minnesota Statute § 12.29, subd. 1.

WHEREAS, the Mayor of Roseville has found that the following emergency situation exists:

- The cities of Minneapolis and St. Paul, Minnesota, have experienced widespread civil unrest since at least May 26, 2020.
- Said civil unrest has included violent and destructive acts that have placed public safety at risk and resulted in near catastrophic property damage.
- The City of Roseville geographically borders both Minneapolis and St. Paul.
- Reports and observations of local law enforcement personnel and emergency first responders establish that as of May 29, 2020, incidents of said civil unrest have been observed within the City of Roseville.
- The law enforcement personnel and emergency first responders for the City of Roseville expect violent and destructive acts of civil unrest to continue and escalate without invocation of certain portions of the City's emergency management plan, as established under Chapter 107 of City Code.

WHEREAS, the Mayor has declared that the situation constitutes a local emergency;

WHEREAS, the City Council agrees with the Mayor's findings and further finds that the local emergency will last for more than three days;

BE IT RESOLVED by the City Council that:

- 1) The local emergency is recognized as continuing until June 8, 2020
- 2) A curfew in the City of Roseville will be in place from 10 p.m. to 4 a.m. on June 1-2 and June 2-3. Additional curfew periods may be declared by the Roseville Emergency Manager during the period of the local emergency.
- 3) This declaration of a local emergency will invoke the City's Emergency Management Plan. The portions that are necessary for response to and recovery from the emergency must be used.

RESOLUTION TO MAKE EXPENDITURES DURING A LOCAL EMERGENCY
WHEREAS, On May 29 th the Mayor of Roseville has declared that a local emergency is in effect;
WHEREAS, On June 1, 2020 the City Council extended the local emergency until June 8, 2020;
WHEREAS, the city council finds that immediate action to respond to the situation is needed in order to protect the health, safety, and welfare of the community;
WHEREAS , the immediate expenditure of city funds is required to respond to the emergency;
WHEREAS, Minn. Stat. § 12.37 provides that during a local emergency, the governing body of a city may enter into contracts and incur obligations necessary to combat the disaster by protecting the health and safety of persons and property and by providing emergency assistance to the victims of the disaster without compliance with procedures, formalities and requirements ordinarily prescribed by law or charter.
BE IT RESOLVED that the City Council authorizes the City Manager to make any and all expenditures necessary to deal with the local emergency on behalf of the City of Roseville.
