# BACKGROUND

Yangsons, Inc. is in the process of purchasing the Hamline Liquors store located at 2825 Hamline Avenue N. Yangsons, Inc. intends to begin operating under the existing trade name, Hamline Liquors, 4

upon the transfer of the license.

Recognizing that the City permits a maximum of ten off-sale liquor licenses, all of which are currently in use, Thanh V. Hoang has agreed to forfeit the rights to his off-sale liquor license upon City Council's approval of the transfer. The license will then be transferred to Yangsons, Inc. for the remainder of 2014.

Under State Statute 340A.412 and City Code Chapter 302.07B, the acquisition of an existing off-sale retail location is effectively categorized as a transfer of an existing license; for which City Council consent is required. The City Code reads as follows:

Person and Premises Licensed; Transfer: Each license shall be issued only to the applicant and for the premises described in the application. No license may be transferred to another person or place without City Council approval. Before a transfer is approved, the transferee shall comply with the requirements for a new application. Any transfer of the controlling interest of a licensee is deemed a transfer of the license. Transfer of a license without prior City Council approval is a ground for revocation of the license.
