- 2 At the April 20, 2009 Council meeting, the Council discussed a proposed resolution giving the
- 3 City Manager authority to seek grant funding from external sources. Grants supplement city
- funds, allowing the city to deliver services in a more cost-effective manner. Certain grants also
- give the city the opportunity to pursue creative activities which may otherwise not be funded.
- 6 Council asked for clarification for when the City Manager would seek grants without Council
- approval and the requirement that the City Manager to notify the Council of any grant
- 8 applications.

## 9 POLICY OBJECTIVE

- Give the City Manager authority to submit grant applications in a timely manner and to report
- any grant application to the City Council.

Potential for the City to receive substantial grant monies which could offset City expenditures.
